Shortlisted candidates will undergo a personal interview, and the final selection will be based on their performance during the interview. There may be a psychometric/aptitude test taken before the personal interview.

## 18. When and where will the personal interviews take place?

Ans. Personal interviews will be conducted in three phases: mid-April, mid-May, and mid-June 2024. Locations include Ahmedabad, Jamshedpur, or Delhi-NCR. Exact dates will be communicated to shortlisted candidates at least 7 days before the interview.

#### 19. How will I be notified if I am shortlisted for a personal interview?

Ans. Shortlisted candidates will be notified through the contact details provided in their application form. Please ensure your contact information is accurate and up to date.

#### 20. When will the final selection results be announced?

Ans. The final selection results, based on personal interview performance, will be communicated within 7 days of the interview. Admission letters will be provided to the selected candidates during this period.

#### 21. Can working professionals apply, and how does the notice period work?
